AUCTION BID BY PROXY RULES

BID BY PROXY

Bid by Proxy will take place with the participant completely filling out the Proxy Bid form. Incomplete and/or illegible forms will be considered null and void. A representative will bid for the item on your behalf using an anonymous Bidder #. Bidding will be done as if you were present and your purchase(s) will be obtained at the lowest bid possible. Bidding will not commence with the highest Proxy Bid. Bids will increase in increments set by the Auction committee.

Example: Your maximum bid is \$1,000 for an item that opens in the live auction at \$100 and increases by \$100 increments. If another bidder bids \$500, your proxy will be \$600. If all other bidders stop bidding, you'll win the item for \$600, not at your maximum bid at \$1,000.

In the event two proxy bids tie for the same item, the proxy bidder who submitted the signed proxy bid first will win the item.

If your proxy bid is the highest at the close of the auction on May 4, 2024, you will be deemed the winning bidder, and agree to pay the amount due in full. You will be notified on or before the next business day following the auction. The purchase will be charged to your credit card.

BIDDING DISCLOSURE

Suggested retail values are only a guide. Participants at the event will determine the real value of each item through the bidding. All sales are final and there will be no exchanges, refunds or substitutions.

TAX DEDUCTIBILITY

According to IRS Rules and Regulations, the only tax deduction for the purchase of auction items from nonprofit organizations is the amount paid in excess of fair market value. We suggest that you contact your tax professional to determine the tax deductions (if any) for your specific purchase(s). Imbler Education Foundation will provide you with a receipt.

AUCTION ITEMS WILL NOT BE RELEASED WITHOUT PAYMENT.

Winning Bidder will be notified by phone or email. ALL SALES ARE FINAL. There will be no exchange or refunds on items. Bidder is responsible for making arrangements to pick-up or receive item(s).

A Credit Card Number is required to participate. Your credit card number will be charged if you are the winning bidder. **Bids MUST be received no later than 9:00pm Friday, May 3, 2024.**
